

STREET-LEGAL SPECIAL PURPOSE VEHICLE INSPECTION

Reference: 2025 Senate Bill 63

There shall be a twenty-five-dollar (\$25) fee payable to the sheriff's office upon completion of the certification and an additional fee of twenty dollars (\$20) per trip when it becomes necessary for the certified inspector to travel to the site of the vehicle rather than bringing the vehicle to the sheriff's inspection area.
